
RESOLUTION NUMBER R- 269509

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with JHK and Associates, for professional engineering services in connection with the design of traffic signal and street lighting systems at Capital Improvements Program locations, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269509.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$32,300 (from: a) C.I.P. 61-002.0, "Annual Allocation - New Traffic Signals", Capital Outlay Fund, \$16,700; b) C.I.P. 62-275.0, "Traffic Signals - FBA Funded" FBA Fund, \$3,600; c) C.I.P. 61-001.0, "Annual Allocation - Signal Installation to Accommodate Sudden Traffic Changes", Capital Outlay Fund, \$12,000), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
