BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager is hereby authorized to inform the U.S. Navy that the City elects to have the Navy accomplish the demolition of all buildings on the Naval Hospital exchange parcel except Building No. 1 (Administration Building) and Building No. 8 (Library/Auditorium) in accordance with paragraph 4(a) of the Final Judgment.
- 2. That the City Auditor is hereby authorized to pay the U.S. Navy the sum of \$1,200,000 plus interest earned to date of disbursement (\$1,909,956 as of 7-1-87) as payment in full for accomplishing the demolition work in accordance with paragraph 4(a) of the Final Judgment.
- 3. That the City Manager is hereby authorized to request the U.S. Navy to include Building No. 29 as a deductive alternate in its call for bids for the building demolition contracts.
- 4. That the City Manager is hereby authorized to request the U.S. Navy to waive the 120 day notice requirement of paragraph 4(b) of the final judgment with regard to landscaping of the Exchange Parcel.
- 5. That the City Manager is hereby authorized to negotiate with the U.S. Navy the terms of an agreement for landscaping of the Exchange Parcel and demolition of Building No. 29 based on bids received by Navy per Item 3.

6. That the City Manager is hereby directed to return to Council with a recommendation relative to landscaping of the Exchange Parcel and demolition of Building No. 29.
