RESOLUTION NUMBER R- 269529

ADOPTED ON OCT 20 1987

WHEREAS, the Council of The City of San Diego has enacted an ordinance relating to shared parking; and

WHEREAS, a Shared Parking Permit shall be required for any mixed or multi-use project which does not meet the provisions of Chapter X, Article 1, Division 8 of the San Diego Municipal Code; and

WHEREAS, the success of a shared parking program requires a five-year review of shared parking permits to determine appropriate parking ratios, and accumulation curves at a cost of \$250,000; and

WHEREAS, the size of a project determines the actual cost of monitoring parking usage, gathering and analyzing data; and


WHEREAS, the Council is desirous of recovering costs associated with the program; and

WHEREAS, for purposes of this resolution, parking spaces are defined as those spaces which total the difference between the shared parking requirement and applications of the accumulation curve to the proposal as calculated by the methodology outlined in Council Policy 600-04; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that establishment of a cost recovery deposit for processing and monitoring a Shared Parking Permit is hereby authorized and approved at the following rate: For the first 199 spaces saved, \$150 per space will be charged. Spaces saved beyond 199 will be charged at the following rate: \$100 per space for the next 200 spaces, and \$50 per space for over 400 spaces saved. Five years after adoption of this resolution, this deposit requirement shall terminate upon completion of the study.
