| Mary Ellen Kruse | Utilities | \$438.71 | Ms. Kruse is an Assistant Lab Technician with the Metro Division. She suggested replacing the hot plate with a microwave oven to heat microbiological media. The actual savings realized were \$2,924.76, in time. This is the remainder of her award. |
| Richard Bowden, Jr. | Fire | \$160.00 | Mr. Bowden is a Captain. He suggested the installing of tear-off lens covers on the Breathing Apparatus face-pieces. Although savings are difficult to identify, this was considered to be a significant operational improvement. |
| Perry Peake | Fire | \$160.00 | Mr. Peake is a Fire Engineer. He suggested issueing a training bulletin on proper safety during rescues involving exposed natural gas pipes. Although savings are difficult to identify, this was considered to be a significant operational improvement. |
| Maria Moran | Utilities | \$160.00 | Ms. Moran is a Plant Operator with the Waste-water Division. She suggested color coding the existing Odor Tower Removal caustic supply system. Although savings are difficult to identify, this was considered to be a significant operational improvement. |
