Eric Dalton Dorothy Norris	Utilities	\$ 39.18 \$137.66	Mr. Dalton is a Lab Technician and Ms. Norris is Biologist II. They suggested using a computer program to log information about lab samples. Actual savings of \$3,510.34, in time realized. This is the remainder of their award.
Deborah Mauney Elizabeth Yard	Park & Recreation	\$ 48.60	Ms. Mauney was an Intermediate Typist and Ms. Yard was an OCA'ing Senior Typist at the time of this suggestion. They suggested establishing a fee for cancellations of rentals of Park & Recreation buildings. Actual savings of \$162 was recouped from cancellation fees. This is their full award.
David Buck	Fire	\$ 45.00	Mr. Buck is a Captain. He suggested utilizing a standard form for logging emergency generator checks. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Sally Stratton	Purchasing	\$ 45.00	Ms. Stratton is a Word Processing Operator. She suggested the beginning of charging contractors for second copies of identical plans and specifications. Although savings are difficult to identify, this was considered to be a significant operational improvement.
