RESOLUTION NUMBER R- 269552

ADOPTED ON OCT 26 1987

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street reservation to be vacated has been impassable to vehicular travel for a period of five (5) consecutive years and no public money was expended for maintenance during such period; and

WHEREAS, the abutting property owners have requested the vacation of the street reservation within Lots 104-113 and 121-126 of Soledad Corona Estates, Unit 2, Map 4192; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the street reservation within Lots 104-113 and 121-126 of Soledad Corona Estates, Unit 2, Map 4192, as more particularly shown on Drawing No. 17085-B, on file in the office of the City Clerk as Document No. RR- 269552 -, which is by

this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

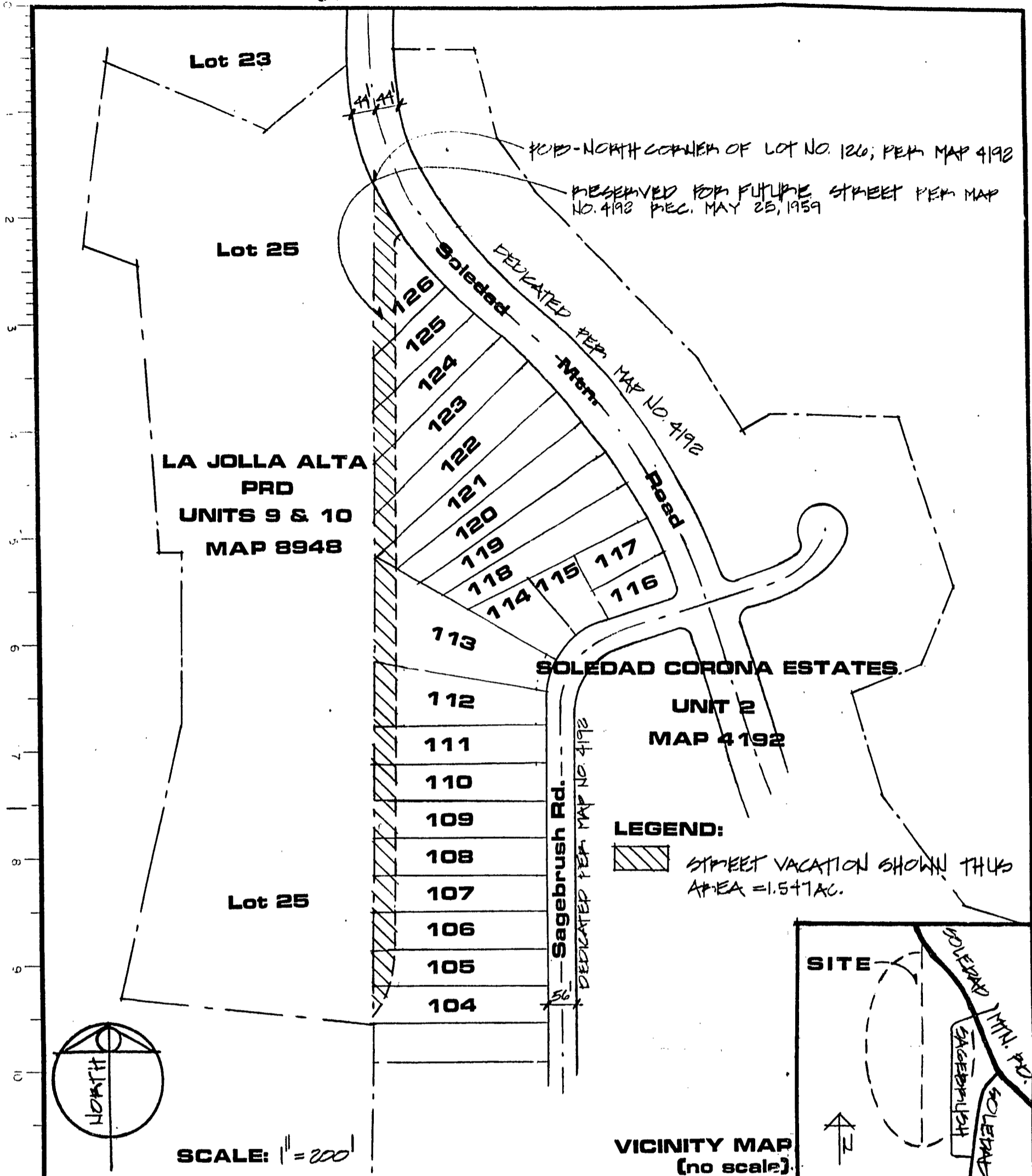
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
