GILDRED and LOMAS SANTA FE, INC.
- 2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR- 269557, quitclaiming to THEODORE E. GILDRED and LOMAS SANTA FE, INC., those certain easements, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
