RESOLUTION NUMBER R- 269583

ADOPTED ON OCT 27 1987

WHEREAS, Resolution No. R-268317, adopted by the Council of The City of San Diego, on May 11, 1987, authorized the City Manager to execute, for and on behalf of the City of San Diego (hereinafter called "City"), an Agreement with Keith Prowse & Co. (USA) Ltd. (hereinafter called "Contractor"), for the provision of Hospitality Facilities at San Diego Jack Murphy Stadium for Super Bowl XXII; and

WHEREAS, an Agreement was executed between the City and Contractor and is on file in the office of the City Clerk as Document No. RR-268317; and

WHEREAS, the Agreement provided for four (4) basic hospitality packages that could be purchased with the option for users to add additional items including entertainment, special decor, additional menu items or additional seating for a specified price from Contractor. The basic hospitality packages are outlined in Exhibit A, attached to Agreement, Document No. RR-268317; and


WHEREAS, pursuant to Section 3. of the Agreement, Contractor would pay the nineteen percent (19%) of the gross revenues from the basic hospitality packages; and

WHEREAS, the Agreement did not specify if Contractor was to pay the City nineteen percent (19%) of the gross revenues from services or products purchased in addition to the basic hospitality packages; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Section 3. of the above-mentioned Agreement be amended to require Contractor to pay the City twelve percent (12%) of all gross revenues from services or products purchased in addition to any of the basic hospitality packages as outlined in Exhibit A.
