WHEREAS, on October 15, 1987, the Planning Commission of The City of San Diego considered a proposed work program for the analysis of the urbanized community development potential and facility availability; and

WHEREAS, the proposed work program is in response to the lack of specific information on the development capacity and facility availability within the urbanized communities that became apparent during the development of the Interim Development Ordinance; and

WHEREAS, the work program is a part of The City of San Diego's long term growth management effort; and

WHEREAS, the work program provides for a two pronged effort for each of the urbanized communities; the determination of development potential considering existing housing stock and vacant and underutilized land; and, the analysis of existing public facilities and their required augmentation to accommodate community plan buildout; and


