RESOLUTION NUMBER R- 269593

ADOPTED ON OCT 27 1987

WHEREAS, the matter of an urgent request for direction from the City Council regarding the County's proposal to locate SA 712 entirely within The City of San Diego was addressed in a Planning Department memorandum, dated October 23, 1987, to the Transportation and Land Use Committee ("Committee"); and

WHEREAS, the Committee unanimously approved the item on October 26, 1987 and directed the matter be forwarded to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Department be and it is hereby directed to pursue, with the State Office of Planning and Research, the issue of Lead Agency role and to prepare a letter to the County Board of Supervisors which (1) objects to the County proceedings with the preparation of the draft EIR as it relates to SA 712; (2) states that the City should be recognized as the Lead Agency in the preparation of any EIR which addresses the location of the road alignment within The City of San Diego; and (3) directs that the applicant submit to The City of San Diego its request for a General Plan amendment.
