WHEREAS, Carl Esenoff began his professional career as a Certified Public Accountant in 1933, established the firm which evolved into Everts & Esenoff, which in turn, became part of Peat, Marwick, Mitchell & Co., and was the first President of the San Diego Chapter of the California CPA Society; and

WHEREAS, over these many years, Mr. Esenoff has devoted himself to numerous organizations in the Jewish community in particular, and the San Diego community in general, which include Congregation Beth Israel, Jewish Welfare Society, Community Foundation of the United Jewish Federation, Federation of Jewish Agencies, United Jewish Fund, San Diego Hebrew Home for the Aged, San Diego Hospital Association, San Diego Chamber of Commerce, Community Chest, Boy Scouts of America, COMBO, Citizens Interracial Committee, San Diego Blood Bank, San Diego Symphony Association, Rotary Club of San Diego, Masonry, Scottish Rite, Shrine, Advisory Committee-San Diego State University and Board of Trustees, California Western University; and

WHEREAS, those involved with the aforementioned organizations and numerous others can attest that Carl Esenoff is an example of the very best in civic spirit and Jewish commitment; and


WHEREAS, Mr. Esenoff has exemplified how life can be lived by the highest principles; and
