BE IT RESOLVED, by the Council of The City of San Diego that the low bid of BLUE SKIES LANDSCAPE MAINT., meeting specifications is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF THE FIVE (5) INTERSECTION ISLANDS AT MISSION VILLAGE DRIVE & FRIARS ROAD, AND THE TWO LARGE BANKS NORTH OF FRIARS ROAD EAST & WEST OF MISSION VILLAGE DRIVE as may be required for a period of one (1) year beginning December 1, 1987 through November 30, 1988, at a cost of \$2,075.00 per month and \$15.00 per hour for extraordinary labor, for a total estimated cost of \$32,400.00 per year (including an estimated 500 hours of extraordinary labor); terms net 30 days, with an option to renew contract for four (4) additional one (1) year periods with a price escalation not to exceed 10% of prices in effect at the end of each prior year.

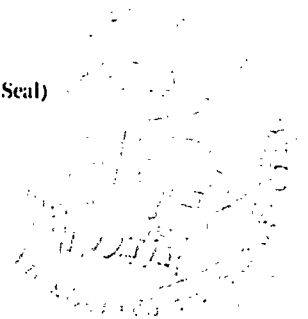
