No. 62-275.0, "Traffic Signals-FBA Funded", FBA Fund, \$6,700, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

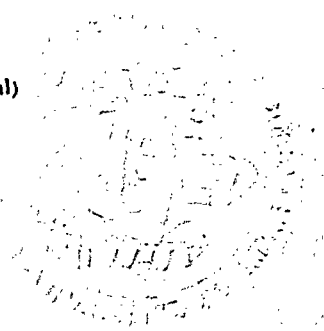
