BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with Sonico Associates, Ltd., for land acquisition in the vicinity of Roselle Street in Sorrento Valley described as Parcel 2 of Parcel Map 14492, together with easements in Parcel 1 of said Parcel Map for Pump Station 64 Force Main II, as previously approved by City Council Resolution No. R-268324 and adopted on May 12, 1987.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered to pay the sum of \$2,252,425, together with related acquisition expenses in the sum of \$7,575, for a total of \$2,260,000 towards the purchase of said property and in settlement of the case, Sonico Associates, Ltd. v. City of San Diego, et al., Superior Court Case No. 569785;

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized and empowered to utilize available funds for said acquisition from the Wastewater Collection Systems

Construction Program Fund 70492, "Pump Station 64" Force Main II, said funds previously authorized by Resolution No. 268777; A.C. 8701017, out of C.I.P. No. 46-118;

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,252,425, together with related acquisition expenses of not more than \$7,575, from the Wastewater Collection Systems Program Fund 70492, C.I.P. No. 46-118 is hereby authorized from the source and under the authority cited above, solely and exclusively for the purpose of providing funds for the above-described acquisition and settlement of Superior Court Case No. 569785 and the additional Sonico claim, provided that the escrow in connection with land acquisition authorized by paragraph 1 of this resolution closes in accordance with the terms and conditions of said escrow.
