RESOLUTION NUMBER R- 269626

ADOPTED ON NOV 2 1987

WHEREAS, the City Council, on Tuesday, September 8, 1987 considered the following:

Matter of the request of Scripps Clinic & Research Foundation, by Richard M. Bracken, for a hearing of an appeal from the decision of the Planning Commission in granting, with conditions, Conditional Use Permit CUP-86-0262, to allow an 87,000 square foot addition to the existing 744,000 square foot Green Hospital, consisting of 23,000 square feet for clinic uses and 64,000 square feet for hospital uses. The subject property is located on the west side of Torrey Pines Road between Genesee Avenue and Science Park Road. University Community Area. (Dist. 1);

and

WHEREAS, the request for appeal was denied by a 6-0 vote, Districts 1, 2, 3, 5, 7 and 8 voting to deny; and

WHEREAS, the Councilmember from District 2 requested the matter be reconsidered by Council as a Special Order of Business; and

WHEREAS, the Permanent Rules of the Council precluded at that time, an automatic reconsideration of the request by virtue of incorporation therein of Council Policy 000-6 and Roberts Rules of Order [set forth in Rule 2]; and

WHEREAS, to effectuate the above-requested reconsideration, it was necessary to invoke Rule 32 which provides a temporary suspension of the Rules so that the previously disposed of matter may be approved for reconsideration by a two-thirds vote of the

Council, said temporary suspension applying only to the specific matter under consideration and for which suspension was requested; and

WHEREAS, it was requested by the Council District 2 Councilmember that Rule 32 be invoked to temporarily suspend the Rules of Council so that the matter may be reconsidered; and

WHEREAS, the matter was reconsidered by Council under Special Order of Business as Item S405 on October 26, 1987, the applicable Rules of Council were waived, and reconsideration granted by a unanimous 8-0 vote; and

WHEREAS, in connection with the grant of reconsideration by Council, the date of January 12, 1988 was established as the day on which the hearing of an appeal would be conducted; and

WHEREAS, it is requested that a hearing on the date set for the appeal be conducted prior thereto in order to provide for completion of the process in a timely fashion to accommodate urgent needs; and

WHEREAS, in accordance therewith, it is requested that should Council concur, a revised hearing date be scheduled for November 24, 1987; NOW, THEREFORE,


