WHEREAS, the City is being granted drainage easements on the final map of Westwood Valley Unit No. 8 subdivision; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 269659 -1, quitclaiming to WESTWOOD VALLEY PARTNERSHIP, all of the City's right, title and interest in the drainage easement in a portion of Ranch San Bernardo, as more particularly described in said deed.

2. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
