WHEREAS, the Symphony provides a medium that showcases the exceptional performing talents and abilities of over eighty music professionals from throughout this community; and



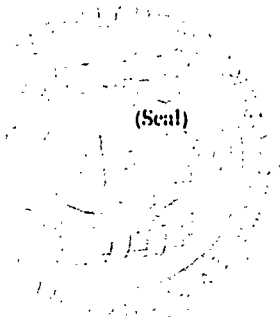
