WHEREAS, it is necessary to return unexpended park and other fees to the subdivider, Techbilt Construction Corporation which were paid by the subdivider; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Auditor and Comptroller is hereby authorized to transfer \$101.00 from Fund 11450, \$191.00 from Fund 11452, \$5,818.00 from Fund 13450 and \$120.00 from Fund 13451 into Fund 11451 and to disburse therefrom the sum of \$7,800 to TECHBILT CONSTRUCTION CORPORATION as a refund of park fees.
- 2. That Council directs that unexpended funds paid by TECHBILT CONSTRUCTION CORPORATION in connection with Greenbelt subdivision be returned to TECHBILT CONSTRUCTION CORPORATION.
