BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GROUP DELTA CONSULTANTS, INC., for engineering design services for the replacement or upgrading of the shoreline protection below the Point Loma Treatment Plant, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269683.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$210,000 within the Sewer Revenue Fund 41506, from the Unallocated Reserve (70697) to the Engineering Wastewater Construction Program (70892), Point Loma Shoreline Protection Project, CIP No. 46-135.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$335,000 from the Sewer Revenue Fund 41506, CIP No. 46-135, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
