APPROVING MAP OF HAZARD CENTER.

Paul, Registered Civil Engineer, entitled "HAZARD CENTER being a subdivision of Parcel 1 of Parcel Map No. 14364, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, July 11, 1986, as File No. 86-286883 of official records, together with a portion of Mission Center Road and Friars Road as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Hazard Center Drive, Frazee Road, portion of Mission Center Road, and a light rail transit right-of-way reservation, and said streets, portion of street and light rail transit right-of-way reservation, are hereby declared to be public streets, portion of public street and public light rail transit right-of-way reservation, and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Friars Road, adjacent and contiguous to Lot 4 and a portion of Lot 2, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across all that portion of Lots 1, 2 and 6, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets, portion of street, and light rail transit right-of-way are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easement(s) with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as well as the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
