WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are approximately equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 269698, quitclaiming to R. E. HAZARD CONTRACTING COMPANY, a California corporation all of the City's right, title and interest in the sewer easement on a portion of Lot 9, Parcel 1 of Parcel Map No. 13791, in exchange for a sewer easement being granted on the final map of Hazard Center Unit No. 1, as more particularly described on said map.

2. That the City Clerk is hereby authorized and directed to deliver the deed, and a certified copy of this resolution to the Engineering and Development Department for further handling.
