BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend a sum not to exceed \$1,410,000 from General Fund 100 and a sum not to exceed \$90,000 from Special Fund 10132, for a total amount not to exceed \$1,500,000, solely and exclusively for the purpose of providing funds for the above project during Fiscal Year 1988.
