
RESOLUTION NUMBER R- 269706

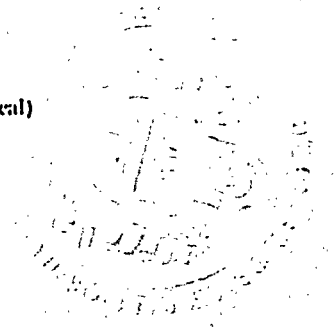
