
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager's recommendation to accept the proposal of Deborah Szekely and Alexander Szekely to donate Lots A, B and C (Parcels 452-495-16, 452-495-17 and 452-495-18) in Uptown Albatross Canyon to the City for open space, is hereby approved.

BE IT FURTHER RESOLVED, that Parcels 452-495-13, 452-495-14 and 452-495-15 are hereby deleted from the City's proposed acquisition list for Albatross Canyon.

BE IT FURTHER RESOLVED, that the excess funds (approximately \$222,000) from the \$1,700,000 authorized by Resolution No. R-269312, adopted September 22, 1987, for acquisition of open space in Uptown Albatross Canyon are hereby directed to be used for other open space acquisitions in the Uptown Community Area.
