- 3. That the expenditure, not to exceed \$60,044 from CIP No. 29-264 PARKSIDE NEIGHBORHOOD PARK DEVELOPMENT to supplement funds previously authorized by Resolution No. 269042, adopted on August 10, 1987, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
