1. SAN DIEGO FIRE EQUIPMENT CO. for Items 3 and 4, Turnout Coats and Liners, for a total estimated cost of \$33,383.00; terms 2% 20 days, plus sales tax, with an option to renew contract for an additional one (1) year period with price increases not to exceed 10% during option period.
2. L. N. CURTIS & SONS for Items 1 and 2, Turnout Pants and Liners, for a total estimated cost of \$37,772.00; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period with price increases not to exceed 10% during option period.
