That the expenditure of an amount not to exceed \$413,510 (\$358,383 from the Human Care Services Special Fund 19660; \$53,707 from CDBG Fund 18522, Dept. 5864, Org. 6404 and \$1,420 from CDBG Fund 18522, Dept. 5864, Org. 6412), is hereby authorized, solely and exclusively to operate six juvenile diversion services.
