
ADOPTED ON NOV 16 1987

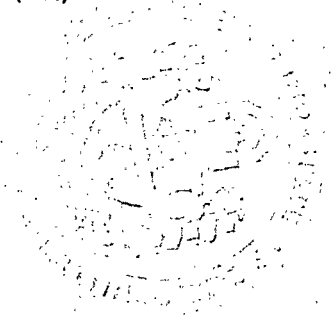
