
BE IT RESOLVED, by the Council of The City of San Diego, that it hereby endorses Alternative A of Planning Department Report No. 87-499 on file in the office of the City Clerk as Document No. RR- 269746, as the recommended land use alternative for planning purposes for the lower San Dieguito River Valley. The concept granting Conditional Use Permits for projects which are specifically designed for compatibility with the development of the San Dieguito River Valley Regional Park should be considered in such planning efforts.

BE IT FURTHER RESOLVED, that for such planning purposes the Council hereby supports the utilization of the existing alignment of SA 728 (along San Dieguito Road, El Camino Real and Via de la Valle) and hereby opposes any off-ramps in the San Dieguito River Valley area.

BE IT FURTHER RESOLVED, that the Council hereby determines that this endorsement of Alternative A is conceptual only and that the adoption of this resolution shall in no way affect the rights of property owners in the Lower San Dieguito River Valley

to utilize and develop their property consistent with applicable laws and regulations.
