ADOPTED ON NOV 17 1987

WHEREAS, the Council of The City of San Diego (the "Council") adopted the La Jolla Planned District Ordinance on April 21, 1986; and

WHEREAS, the Council amended the La Jolla Planned District Ordinance on September 29, 1987, to incorporate a building demolition process; and

WHEREAS, the amendment provides that specific sites are to be reviewed for historical and architectural significance prior to the approval of a demolition permit; and

WHEREAS, all applications for a demolition permit in the La Jolla Planned District are to be reviewed by the Planning Director within ten (10) days of receipt; and

WHEREAS, applications for demolition permits of sites deemed by the Planning Director to warrant greater review for historical and architectural significance will be forwarded to the Historical Site Board for its determination and approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code Sections 101.0204 and 103.1204, a fee/deposit of fifty dollars (\$50.00) for initial Planning Director review and five hundred dollars (\$500.00) for Historical Site Board review and determination shall be


