RESOLUTION NUMBER R-269769

ADOPTED ON NOVEMBER 17, 1987

WHEREAS, on November 17, 1987, the Council of The City of San Diego ("Council") considered the Interim Development Ordinance ("IDO") Accelerated Variance Application No. 87-2260, by Kenneth Rodger Casey, Planning Report No. 87-574, to construct one (1) new unit and one (1) replacement unit on the parcel at 1735 Cable Street, zoned R-1750 (25 du/ac). The site is approximately three thousand five hundred (3,500) square feet. Three (3) off-street street-accessed parking spaces will be provided; exterior - stucco; and roof - asphalt shingles, in the Ocean Beach Community; and

WHEREAS, the request for Accelerated Variance submitted by Kenneth Rodger Casey pursuant to the IDO Section 7.B.3., that the project shall consist of not more than three (3) dwelling units or not more than three (3) multi-family dwelling units on a single lot; and

WHEREAS, the request for Accelerated Variance submitted is governed by IDO Section 7.B.4., pursuant to which units granted will be taken from the reserve allocation as set forth in Schedule A of the IDO as modified by the procedures set forth in Resolution No. R-269742 adopted by the Council on November 16, 1987; and

WHEREAS, in arriving at their decision, the Council considered the staff report, the decision of the IDO

Administrator, reviewed the plans and materials submitted prior to and at the public hearing, and heard public testimony presented at the hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the application for Accelerated Variance of Kenneth Rodger Casey is hereby granted, and, therefore, overturns the decision of the IDO Administrator.

BE IT FURTHER RESOLVED, that in arriving at its decision, the Council made the following findings:

1. Construction on the project will be substantially complete within one (1) year of granting the Accelerated Variance. Further requests for extensions beyond the one (1) year period or for expansions of bulk, use or density will not be permitted.

2. Has cooperated with the City abatement of a public nuisance. Project esthetically enhances the community.

3. Units are available from future quarterly allocations of the community based on Resolution No. R-269095, Schedule A.

4. The project is consistent with the adopted Community Plan, and Progress Guide and General Plan. There are no applicable Community Plan revisions pending.

5. The project complies with applicable zoning.

6. A construction delay on the project would significantly impede the ability of Kenneth Rodger Casey to proceed at some future time.

7. Absent growth management provisions of the IDO necessitating the application and approval process described in Sections 6. and 7. of the IDO, the project could proceed.

8. Length of ownership and occupancy plans demonstrate substantial commitment to community welfare and fostering the Community Plan.


9. Kenneth Rodger Casey has presented financial evidence of readiness to proceed.
