RESOLUTION NO. R 269776Adopted on NOV 23 1987

Jack Salfen Matt Decker Robin Bowman	Utilities	\$1,185.67	Mr. Salfen is a Wastewater Lead Operator, Mr. Decker is an Equipment Technician II, and Mr. Bowman is a Machinist. They suggested installation of a one inch copper pipe from gland seal water pumps to PDC's four, five, and six. This is expected to save \$3,952.23 in time and materials. This is a partial award pending a 12-month review.
Ronald Larmour	Police	\$ 643.50	Mr. Larmour is a Detective. He suggested providing business cards for Detectives. This is expected to save \$4,290 in time and materials. This is a partial award pending a 12-month review.
Walter O'Leary Jay Senior	Utilities	\$ 500.00	Mr. O'Leary is a Principle Water Utility Supervisor and Mr. Senior is a Water Utility Supervisor. They suggested the use of a new product called "Rapid Set" instead of Ready Mix or Portland Cement. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Alan Souza	Utilities	\$ 500.00	Mr. Souza is an Equipment Operator II. He suggested the placement of metal grates on top of the Weir Boxes at the decant ends of drying beds. Although savings are difficult to identify, this was considered to be a significant operational improvement.
