Felipa Parel	Building Inspection	\$320.00	Ms. Parel is a Building Inspection Technician III. She suggested the redesign of the City-wide zoning compliance correction sheet. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Bradley Snyder	Purchasing	\$160.00	Mr. Snyder is a Stock Clerk. He suggested the elimination of two stock clerk positions in the Central Stores Division. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Michael-David Blaylock	Police	\$160.00	Mr. Blaylock is a Police Agent. He suggested upon confirmation of warrants, rather than have the arresting officer pick up the warrant at the Marshall's Office, an abstract of the warrant be sent directly to the intake office of San Diego County Jail. Although savings are difficult to identify, this was considered to be a significant operational improvement.
John Chaffin	Utilities	\$100.00	Mr. Chaffin is an Assistant Chemist. He suggested the improvement of the speed and accuracy of pesticide analysis by gas chromatography. Although savings are difficult to identify, this was considered to be a significant operational improvement.
