Daryl Wehrhan	Utilities	\$25.00	Mr. Wehrhan is a Wastewater Plant Operator. He suggested installing handrails on Carbon Towers (over clairifiers) at odor removal towers. Although savings are difficult to identify, this was considered to be a significant operational improvement.
