BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by STEPHEN K. GOODE, Licensed Land Surveyor, entitled "PARCEL MAP NO. TM-86-0368 being a division of Parcel A of Parcel Map No. 519, filed in the office of the County Recorder of San Diego County, May 4, 1971, being a redivision of Lots 123, 124 and 125 of Halecrest Heights Unit No. 1, in the County of San Diego, State of California, according to map thereof No. 4747, filed in the office of the County Recorder of San Diego County, April 19, 1961," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Lincoln Place and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council and that said Council has approved said parcel map, and that said portion of a street is accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement(s) over, upon or across all that portion of Parcel 2, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
