


RESOLUTION NUMBER R- 269804

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to enter into lease negotiations with DANIEL J. AULD and GERALD O. MOHR, for the renovation and operation of a coffee shop/bait and tackle concession located on the Ocean Beach Municipal Fishing Pier.

BE IT FURTHER RESOLVED, that the City Manager is directed to negotiate a provision to be placed in the proposed lease to provide reasonable terms pursuant to which the City may terminate the lease in the event the City Council is not satisfied with the operations conducted by the lessee.
