RESOLUTION NUMBER R- 269806

ADOPTED ON NOV 23 1987

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, an agreement between The City of San Diego and SAN DIEGO UNIFIED SCHOOL DISTRICT, pursuant to which the City may acquire the Farnum Elementary School site, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR- 269806.

BE IT FURTHER RESOLVED, that the agreement is conceptual only and that future Council action will be required in connection with the budgeting and setting aside of funds for acquisition costs; in connection with the development of an appropriate lease from the City to the School District of a portion of the Keiller Park site; in connection with the continued use of the Farnum site by the School District pending the future construction of library on a portion of said site; in connection with the continuing use by the City of the Pacific Beach library site pending the construction of a library on the Farnum site; in connection with the potential future budgeting and authorization of funds for reacquisition of the Pacific Beach library site in the event that site is not conveyed by the School District to the San Diego Community College District; and in connection with the authorization of funds for improvements to the Keiller Park site.
