
ADOPTED ON NOV 23 1987

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,121,144 from Gas Tax Fund No. 302191, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above contract and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
