BE IT RESOLVED, by the Council of The City of San Diego, that, pursuant to Section 43(b) of the San Diego City Charter, a City Charter Review Committee is hereby established for the sole and exclusive purpose of reviewing the current City Charter and recommending amendments and revisions, if any, to the City Council for appropriate action.


BE IT FURTHER RESOLVED, as follows:

1. The membership of said Committee shall consist of fifteen (15) members, all of whom shall serve without compensation, to be appointed by the Mayor pursuant to the provisions of Council Policy 000-13.

2. The Committee shall include within the above specified membership, one (1) representative from each Council District; provided, however, that any Council Policy with respect to appointments to Commissions, Boards and Committees notwithstanding, the Mayor shall appoint such representative members to this Committee by obtaining three nominations from each Council District and appointing therefrom.

3. The Mayor shall designate one (1) member as chairperson.
