

RESOLUTION NUMBER R- 269823

ADOPTED ON NOV 24 1987

WHEREAS, on July 14, 1987, the Council of The City of San Diego adopted the PENINSULA COMMUNITY PLAN AND LOCAL COASTAL PROGRAM LAND USE PLAN with the condition that, as an element of the plan implementation program, additional development guidelines be added to the plan for the Roseville Commercial area designated on Zone Map Drawing No. C-744 and for the block bounded by Nimitz Boulevard, Keats, Rosecrans and Locust Streets; and

WHEREAS, on September 17, 1987, the Planning Commission approved and recommended adoption by the City Council of additional community plan development guidelines for the Roseville Commercial area and for the block bounded by Nimitz Boulevard, Keats, Rosecrans and Locust Streets; and


