## RESOLUTION NUMBER R-269824 ADOPTED ON NOVEMBER 24, 1987

WHEREAS, the Council of The City of San Diego (Council) adopted the Interim Development Control Ordinance (IDO) on July 21, 1987; and

WHEREAS, on September 14, 1987, the Council adopted an amendment to the IDO, which included as Section 4D a method whereby the permissible intensity of development within specific consolidated communities could be increased as an amendment to the community plan called "released communities"; and

WHEREAS, potential community plans are subject to determination by the planning department in conjunction with community experts and communities under consideration have been subject to public hearings and a finding has been made that there is a need for the community to be released; and

WHEREAS, a publicly noticed hearing was held on November 24, 1987, where the Council reviewed materials provided by staff, and heard public testimony regarding proposed guidelines and criteria to be used in the city-wide analysis mandated by the IDO in order to release communities from the IDO via amendments to individual community plans; NOW, THEREFORE,

BE IT RESOLVED, that each community seeking release from the IDO must be analyzed for community-wide public facility needs and impact associated with development by including all of the following:
