BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF RANCHO BERNARDO MEDIANS IMPROVEMENTS in accordance with the specifications.

BE IT FURTHER RESOLVED, that the expenditure of funds previously authorized by Resolution No. 268797, adopted on July 13, 1987, is hereby reauthorized for the above purpose.
