RESOLUTION NUMBER R- 269862

ADOPTED ON NOV 30 1987

WHEREAS, The City of San Diego, by Resolution No. R-269401, dated September 29, 1987, authorized the expenditure of \$100,000 to purchase the San Ysidro Boys Club property and facilities; and

WHEREAS, in connection with said facility, Mrs. Irving Salomon has indicated her desire and intention to donate a similar sum of \$100,000 to be used for the restoration of said San Ysidro Boys Club property; and

WHEREAS, the donation by Mrs. Salomon is predicated upon:

(1) The gift being made and accepted in calendar year 1987;

(2) The facility to be named as the Irving Salomon Community Center, or other such appropriate name which includes the wording "Irving Salomon" as agreed upon by the City and donor, to be evidenced by exterior lettering on the building in an appropriate place and in an appropriate size;

(3) The City shall install in an appropriate place a bronze plaque approximately one foot square with the inscription "Donated by Mrs. Irving Salomon in memory of her husband, Irving Salomon [with the date of dedication of the building]";

and


WHEREAS, it is understood that the facility will be restored and then leased to an appropriate charitable organization for operation and management; and

WHEREAS, it is now deemed appropriate for Council to accept, by Council action, this very generous donation of \$100,000 to the City for the above recited purpose; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby accepts the generous donation of \$100,000 from Mrs. Irving Salomon, to be used for the restoration of the San Ysidro Boys Club property, under the conditions recited above.

BE IT FURTHER RESOLVED, that this Council, for and on behalf of all the people of San Diego, does hereby extend this expression of gratitude and thanks to Mrs. Irving Salomon for this generous act of civic concern and dedication for such donation in the memory of her husband Irving Salomon.
