
ADOPTED ON NOV 30 1987

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$1,200,000.00 in the settlement of each and every claim against The City of San Diego, its agents and employees, Superior Court Case No. 494841, Rita Bradley, et al. v. City of San Diego, et al. resulting from the personal injuries to Rita Bradley.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue three checks, one check in the amount of \$662,800.00 made payable to Donna Bradley, conservator for Rita Bradley; a second check in the amount of \$337,200.00 made payable to Girardi, Keese and Crane, attorneys; and a third check in the amount of \$200,000.00 made payable to Royal Insurance Company and its attorneys McCormick & Mitchell.
