RESOLUTION NUMBER R- 269889

ADOPTED ON DEC 1 1987

WHEREAS, the Council of The City of San Diego adopted the Gaslamp Quarter Planned District Ordinance on July 14, 1976; and


WHEREAS, the City Council amended the ordinance on January 22, 1985, and established that a special permit, approved by the Planning Director, must be obtained prior to application for any City permit or license within the Gaslamp Quarter Planned District; and

WHEREAS, at the time of the above-mentioned amendment, the City Council established a single fee to recoup the costs of processing the applications for special permits; and

WHEREAS, given the considerable staff time and coordination with other City departments, a tiered fee/deposit structure is needed for actual cost recovery; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the following fee/deposit structure be established to defray the cost of processing applications for Gaslamp Quarter Special Permits pursuant to San Diego Municipal Code Sections 101.0204 and 103.0403: a ten dollar (\$10.00) fee for business license tax review; a sixty-five dollar (\$65.00) fee for signage review; a two hundred fifty dollar (\$250.00) deposit for review of alcohol beverage sale and minor improvement projects; and a one thousand five hundred dollar (\$1,500.00) deposit for review of new construction/major projects.

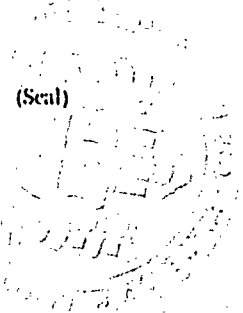
