RESOLUTION NUMBER R- 269899

ADOPTED ON DEC 7 1987

WHEREAS, the late Dr. Martin Luther King, Jr. had a profound impact on the history of America through his courageous assaults on racial prejudice, his commitment to nonviolence, and his concern for the injustice suffered by anyone; and

WHEREAS, Dr. King received the Nobel Peace Prize in 1964 and was the youngest man and third Black to ever receive that prestigious award; and

WHEREAS, he was the author of four books, an eloquent orator and minister, and a frequent guest on radio and television; and

WHEREAS, Dr. King, a man of service and dedication to all of those who suffer discrimination, stated in his last sermon: "I'd like somebody to mention that day that Martin Luther King, Jr. tried to give his life serving others, and I want you to say that day I tried to love and serve humanity;" and

WHEREAS, on January 16, 1988, San Diego will celebrate Dr. Martin Luther King, Jr.'s life with a parade which will follow Market Street, a street which transverses a number of diverse communities in San Diego and exemplifies what Dr. King stood for by including everyone in this event; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, for
and on behalf of all the citizens in San Diego, that January 16,
1988 be and is hereby proclaimed to be "DR. MARTIN LUTHER
KING, JR. PARADE DAY" in San Diego.
