RESOLUTION NUMBER R- 269900

ADOPTED ON DEC 7 1987

WHEREAS, there are more than 5,000 homeless men, women and young people in the San Diego county region, and 3,000 of these individuals congregate in the downtown area; and

WHEREAS, the San Diego community continually responds to problems of the homeless with appropriate programs and effort to assist them through some of the most difficult times in their lives; and

WHEREAS, during the 1986 Christmas season, the City opened its doors and, with the support of hundreds of volunteers, sheltered the homeless; and

WHEREAS, during this year, 1987, the Year of Thanksgiving, San Diego citizens are once again showing their concern by helping the homeless through the Church Interfaith project, nutrition projects, and the Mayor's Christmas Shelter project; and


WHEREAS, Mayor O'Connor, as Chair of the Regional Task Force on the Homeless, will be organizing a benefit for the homeless on December 14, 1987 at the Lyceum Theatre; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the period December 14 through December 31, 1987 be and it is hereby declared to be "Helping the Homeless Days" in San Diego.

BE IT FURTHER RESOLVED, that all citizens are encouraged and urged to participate in the various volunteer programs to

demonstrate their concern and willingness to help alleviate this American tragedy and bring it to an end.
