WHEREAS, WALTER T. SCHWERIN and PAMELA S. HUGENROTH have requested an exchange of sewer easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of that deed of WALTER T. SCHWERIN and PAMELA S. HUGENROTH, executed in favor of The City of San Diego, bearing dates of July 10 and July 11, 1986, conveying to said City a sewer easement in a portion of Lot 45, Block 58, H.M. Higgins Addition, Map 309, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 269914, -1 is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 269914, -2 quitclaiming to WALTER T. SCHWERIN and PAMELA S. HUGENROTH all of the City's right, title and interest in the sewer easement in a

portion of Lots 43 and 44, Block 58 H.M. Higgins Addition, Map 309, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to cause both deeds, and a certified copy of this resolution, to be recorded in the office of the County Recorder.
