ADOPTED ON DEC 7 1987

WHEREAS, during the 1983 CDBG allocation cycle, funds were approved to begin a revitalization effort in the Mid-City area by targeting resources to three (3) demonstration blocks; and

WHEREAS, by Resolution No. R-259886, adopted January 3, 1984, the Commercial Revitalization Loan Program was approved whereby monies were set aside for a loan program enabling owners of property located within these demonstration blocks to finance their property improvements at a fixed, below-market rate; and


WHEREAS, by Resolution No. R-265316, adopted March 31, 1986, the Council of The City of San Diego approved an extension of the geographic boundaries for the Program; and

WHEREAS, further analysis and input from the Mid-City Revitalization Task Force, indicates further expansion of the Program's geographic boundaries is desirable; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that extension of the Commercial Revitalization Loan Program's boundaries is hereby approved to include:

1. Park Boulevard from Meade Street to Adams Avenue;
2. Adams Avenue from Park Boulevard to Florida Street; and
3. El Cajon Boulevard from Park Boulevard to Interstate 805.
