

RESOLUTION NUMBER R- 269931

ADOPTED ON DEC 7 1987

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of 1. TOYOTA-CARLSBAD, 2. PEARSON FORD, 3. CAMPUS FORD, 4. KEARNY MESA DODGE, 5. DREW FORD, 6. HAGEN CHEVROLET, 7. SOUTH BAY CHEVROLET, and 8. COURTESY CHEVROLET, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LIGHT DUTY VEHICLES as follows:

1. TOYOTA-CARLSBAD for Item 1 - thirty-one (31) each compact pickup truck, long bed (Toyota 8132) at a cost of \$7,198.00 each, for a total cost of \$223,138.00; terms net 20 days, plus sales tax.
2. PEARSON FORD for Item 2 - twelve (12) each compact sedan (Ford Escort) at a cost of \$6,425.00 each, for a total cost of \$77,100.00; terms net 30 days, plus sales tax.
3. CAMPUS FORD for Item 3 - one (1) each intermediate station wagon (Ford Taurus) at a cost of \$11,371.67; terms 4.5% 10 days, plus sales tax.
4. KEARNY MESA DODGE for Item 4 - eight (8) each one-half ton standard pickup truck (Dodge D150) at a cost of \$9,147.51 each; Item 5 - two (2) each three-quarter ton standard pickup truck (Dodge D250) at a cost of \$9,914.88 each; Item 6 - seven (7) each one-half ton 4X4 pickup truck (Dodge W100) at a cost of \$10,714.25 each; for a total combined cost of \$168,009.59; terms 1/2% 21 days, plus sales tax.
5. DREW FORD for Item 7 - two (2) each one-quarter ton 4X4 pickup truck (Ford Bronco) at a cost of \$13,909.65 each; Item 9 - fourteen (14) each panel van 9000 GVW (Ford E350 Cargo Super Van) at a cost of \$12,505.93 each; for a total combined cost of \$202,902.32; terms net 20 days, plus sales tax.
6. HAGEN CHEVROLET for Item 8 - three (3) each compact cab and chassis (Chevrolet CS10803) at a cost of \$7,720.00 each; Item 12 - five (5) each cab and chassis 7.5M (Chevrolet CC30903) at a cost of \$9,660.00 each; for a total combined cost of \$71,460.00; terms net 20 days, plus sales tax.
7. SOUTH BAY CHEVROLET for Item 10 - three (3) each Redi Van 10M (Chevrolet CG31603 Harbor Body) at a cost of \$16,879.76 each; Item 11 - two (2) each step van 10M (Chevrolet CP31042) at a cost of \$17,085.17 each; Item 15 - one (1) each cab and chassis 10M 4X4 (Chevrolet CV31003) at a cost of \$13,558.41; for

a total combined cost of \$98,368.03; terms net 20 days, plus sales tax.

8. COURTESY CHEVROLET for Item 13 - one (1) each cab and chassis 4X4 7.5M (Chevrolet CV31003-ZW9) at a cost of \$11,949.00; Item 14 - nine (9) each cab and chassis 10M (Chevrolet CR31003) at a cost of \$10,762.00 each; for a total combined cost of \$108,807.00; terms net 20 days, plus sales tax.
